INTRODUCTION, REGULATIONS AND DUTIES

Module one clarifies the definition of "Working at Height", and provides statistics for the most commonly experienced incidents in the UK. We also look at the UK regulations (WAHR 2005) that govern this work and the legal responsibilities that employees and employers hold with this type of work.

The key learning points are:

- What defines "Working at Height"?
- Which occupations commonly require height-related tasks.
- The types of many accidents and injuries that occur during this work.
- The UK regulations that cover height-work (WAHR 2005).
- The responsibilities of employees and employers hold.



ASSESSMENT AND PREVENTION

In Module two, we explore the full process of applying risk assessment to planned work, where height-related tasks are required to be performed. It details the many types of hazards you can expect to encounter and how to prevent or minimise the opportunity for any harm to befall anyone.

The key learning points are:

- The full procedure for performing a risk assessment.
- Explaining the 5 major stages of an assessment.
- Understanding who could be affected by the planned work.
- The factors that affect risk mitigation.
- The control measures that can be introduced into the workplace to prevent accidents.

WORK AT HEIGHT EQUIPMENT

In Module Three, the course examines the many types of equipment that a worker can expect to use during work at height. This leads to guidelines of how best to use devices such as MAWPs and Scaffolding, and the crucial inspection pointers for devices such as step-ladders and podium steps.

The key learning points are:

- The selection process of work at height equipment.
- The special kinds of PPE that are associated with fall protection.
- The appropriate and safe use of MEWP devices.
- How to effectively inspect ladders and other equipment before use.
- All the considerations and safety protocols to be used with scaffolding.
