How this qualification will be assessed?

To pass the Door Supervisor course you will have to sit four multiple choice question examinations:

- ✔ **Unit 1:** 72 multiple choice questions with a duration of 1 hour 50 minutes and a pass mark of 51 questions.
- ✔ **Unit 2:** 50 multiple choice questions with a duration of 1 hour 15 minutes and a pass mark of 35 questions.
- ✔ **Unit 3:** 20 multiple choice questions with a duration of 30 minutes and a pass mark of 14 questions.
- ✔ **Unit 4:** 30 multiple choice questions with a duration of 45 minutes and a pass mark of 24 questions.

Where can you work?

Any business selling alcohol, including small pubs, retailers, large nightclubs, cafés, restaurants, hotels, sports facilities, warehouses, and construction sites may need trained security staff qualified as door supervisors who hold an SIA licence.
